During the trip, Dr. Perkins talked with a few state legislators who he said were in support of the BSA. The Legislators Perkins met with; Representative Greg Nibert from Chavez county and Senator Roberto Gonzales from Taos county, expressed interest in supporting the BSA and could be potential persons of interest to follow up. Senator Gonzalez mentioned he was friends with the Governor and would be willing to speak to her on behalf of the BSA.

Through screen share, CTO Jones presented an overview on Palladium Diagnostics. Palladium Dx Palladium Diagnostics was founded in 2021 as an aim to be a research manufacturing partner for selling rapid diagnostic testing. During Covid, there was an expansion in the diagnostic testing market with companies becoming familiar with rapid assay testing who did not have the technology before. Founders CTO Jones and Jeff Bauer, President and CEO, had experience with diagnostic testing



and rapid assays before covid as their experience goes back to the late 80's and early 90's.

At the August Finance Committee Meeting, members suggested the board to discuss the potentiality of the BSA's participation in the 2024 BIO Conference in San Diego, California. At the moment, the BSA's budget is constricted, However, the committee iterated their desire to support participating in the conference but needed to find out if the federal appropriations will be awarded before proceeding with a verbal commitment.
Executive Director Tofighi opened the floor for discussion sharing the current 2024 BIO Conference funding request per NMBSA Director Greg Byrnes.
The Chair provided his input by thanking Director Byrnes for his ability in collecting multiple sources of funding annually to represent New Mexico at every planned BIO Conference. In terms of funding, the BSA could use more marketing dollars at the state level to put into these events such as BIO considering New Mexico is an emerging bioscience according to a recent report from Coldwell Banker Richard Ellis, a global commercial real estate conglomerate. In moving forward, the Chair informed the BOD if the funding request is awarded from Senator Heinrich's Office, the BSA will be able to make a substantial donation to Director Greg Byrnes for the 2024 BIO conference. If the funding is not awarded from Senator Heinrich, the Chair said he will search for alternative plans. Director Byrnes responded to the chair stating that a commitment has been made to utilize 800 square feet at the 2024 BIO conference and it is with great imparity that the BSA participates in the 2024 conference. From a collaborative point of view, the BSA needs to be part of this event he said. Director Prisca Tiasse asked for more details on the funding. ED Tofighi said the budget is constrained but the Carryforwards could be utilized for funding. We also have the Co-Investment bill that is up for consideration she said. Tofighi said the BOD needs to think about the budget in terms of flexibility to participate in events such as BIO. The amount of funds

These measures would address gaining support from the Governor.
		With respect to the budget, the committee also discussed if the 2024 Legislative Session would be appropriate to ask for additional resources to advance the BSA's mission and impact throughout the state. The Chair said a decision will be made on how to address the request either by committee or the formation of a task force.
